Members who fail to pay their renewal dues within 60 days of the email will lose their membership. Section VI: CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

As a condition of membership in the Filipino American Chamber of Commerce of Greater Houston (“FACCGH” or the “Chamber”), the undersigned individual or business entity (the “Member”) acknowledges and agrees that these confidentiality obligations apply to the Member and, if the Member is a business or organization, to all individuals designated or acting as representatives under the Member’s Corporate Membership. The Member agrees to ensure that all such representatives are informed of and comply with these confidentiality obligations and accepts responsibility for any breach of these obligations by its representatives.

1. Confidential Information

The Member may receive non-public, proprietary, or confidential information relating to the Chamber, its members, officers, committees, sponsors, partners, or activities, including but not limited to membership information, contact lists, financial or sponsorship information, internal discussions, meeting materials, strategies, and other information that a reasonable person would consider confidential (“Confidential Information”).

2. Non-Disclosure and Limited Use

The Member agrees to keep all Confidential Information confidential and to use such information solely for legitimate Chamber related purposes. Confidential Information shall not be disclosed, shared, or used for personal, business, or competitive advantage without the prior written consent of the Chamber.

3. Non-Circumvention and Non-Solicitation

The Member agrees not to use Confidential Information to contact, solicit, or transact directly with any member, sponsor, partner, or contact introduced through the Chamber for personal or commercial purposes without the Chamber’s consent. This obligation applies during membership and for two (2) years after membership ends.

4. Exclusions and Required Disclosure

Confidential Information does not include information that is publicly available through no fault of the Member, lawfully known prior to disclosure, lawfully obtained from a third party, or independently developed. If disclosure is required by law or court order, the Member shall provide notice to the Chamber when legally permitted and disclose only the information required.

5. Return or Destruction

Upon request by the Chamber or upon termination of membership, the Member shall return or permanently delete Confidential Information in the Member’s possession.

6. Duration and Remedies

Confidentiality obligations apply during membership and continue indefinitely with respect to information disclosed during the membership period. The Member acknowledges that unauthorized disclosure may cause harm to the Chamber and that the Chamber may seek legal or equitable relief.

7. Governing Law

This provision is governed by the laws of the State of Texas, with venue in Harris County, Texas.
